## **Teen Golfer Competes to Support Caregivers of Alzheimer's Patients**

MARIETTA, Ga. (September 9, 2019) – 14-year-old Ethan Smith, who is currently ranked second in the class of 2024 in Georgia and  $48^{th}$  in the country, has dedicated his summer to raising funds for caregivers of Alzheimer's patients. Throughout this year's golf season, several donors have pledged to make a donation for every birdie Ethan hits.

"I am so proud of Ethan for utilizing his talents to help others," said Ethan's father Casey Smith. "In watching our friends care for a loved one with dementia, we have seen the toll it takes on entire families."

Casey Smith serves on the board of <u>The Laona M. Kitchen (LMK) Foundation</u>, which was founded to honor Laona Kitchen, who battled Alzheimer's disease. The LMK Foundation partners with the WellStar Foundation to assist families caring for loved ones with Alzheimer's and other dementias.
