PRESIDENT'S MESSAGE

The fall of 2019 was a busy one for Edmonton Branch. September 4th was our Fall General Membership Meeting (GMM). September 11th & 12th we were in Yellowknife meeting with members and recruiting new members.

September 18^{th} , we met with members in Grande Prairie and October $6^{th} - 8^{th}$ was the Regional Meeting in Red Deer with other Alberta branches. Mixed in with this was advocacy activities for the October 15^{th} Federal Election as well as planning for our on-going recruiting activities and our Winter/Christmas GMM on December 4^{th} . Details on these are elsewhere in this newsletter.

For the December 4th, 2019 GMM, all members are encouraged to "Bring a prospective member" and both you and the prospective member will be entered into a prize draw. If the prospective member joins within 60 days, both of you will be entered into a second prize draw. This is in addition to any prizes you may win in the national MEGA recruiting drive that was announced in the fall edition of Sage which ends on December 15th.

Our trip to Yellowknife was both busy and fruitful. We were breaking new ground by seeking to recruit from amongst currently working NWT Territorial employees, as well as current Federal employees. We presented to fifty-one individuals on the benefits of membership in NAFR and also provided them with information on their pension plan. By early October we had 29 new members, consisting of 13 couples and 3 singles. Our experience in Edmonton suggests that new members will continue to join for at least several months. There are about 5,300 Territorial employees and 500 federal employees in the NWT and an unknown number of current retirees. With just under 300 NAFR members at present, there is a lot of potential for growth. The presentation on the Public Service Pension Plan by a certified presenter, a topic that all current employees are anxious to hear more about, brings them in the door and the benefits of membership convinces them to sign up. We were a relatively unknown organization on this first trip, but I believe that knowledge of us will continue to spread as attendees talk to their friends and colleagues. We are planning to return in 2020 to build on our success. Also in the recruiting area, we will be repeating our Pension Information Sessions in Edmonton on January 25th and February 1st, 2020.

As you know, we have three General Membership Meetings each year, in May, September and December. A meal is enjoyed, branch business is conducted, and a limited amount of time is available for presentations on topics of interest to our members.







In 2020, we are going to pilot stand-alone information sharing sessions with two or three presentations of interest to members. These will be afternoon sessions that will include coffee, tea, etc. and a light snack. If it is as successful as we anticipate, they will be repeated (on other topics) two or three times per year. ADVOCACY AND RECRUITMENT
